Determinants of Non-State Governance Success: Hezbollah in Lebanon

Abstract

Why are some non-state governance actors highly successful while others are bound to fail? Hezbollah, a Shia Islamist political party and militant group headquartered in Lebanon, is widely accepted as one of the world's most premier non-state violent actors. As a highly capable organization, it is exemplary of the extent to which non-state governance can function and develop in a parallel manner to its respective state entity. So, what accounts for Hezbollah's widespread success? **I argue that Hezbollah's success in Lebanon is due to its political legitimacy, which is obtained and consolidated through its welfare provision scheme, political power, and organizational characteristics.** I define success as political legitimacy. I aim to contribute to our understanding of what predicts non-state governance success, and challenge traditional notions of statehood and governance.

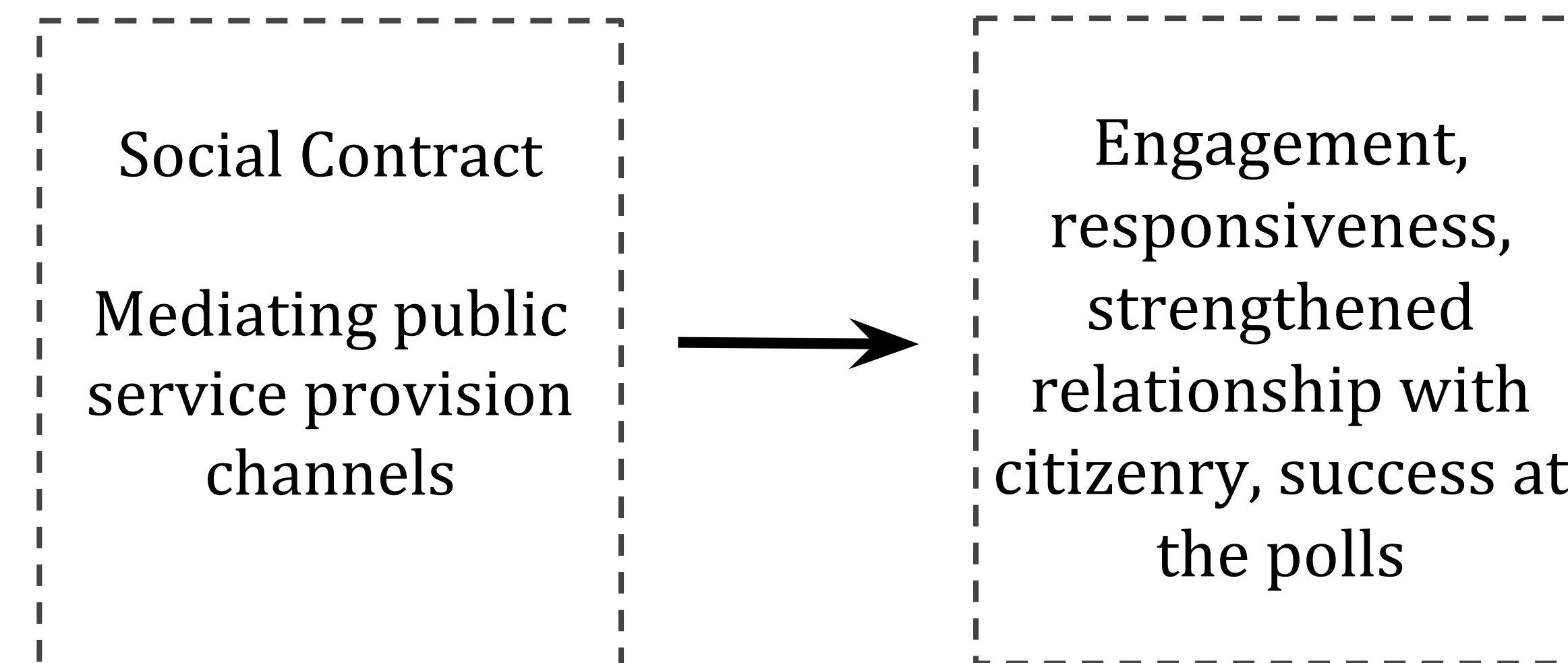


Hezbollah's areas of control

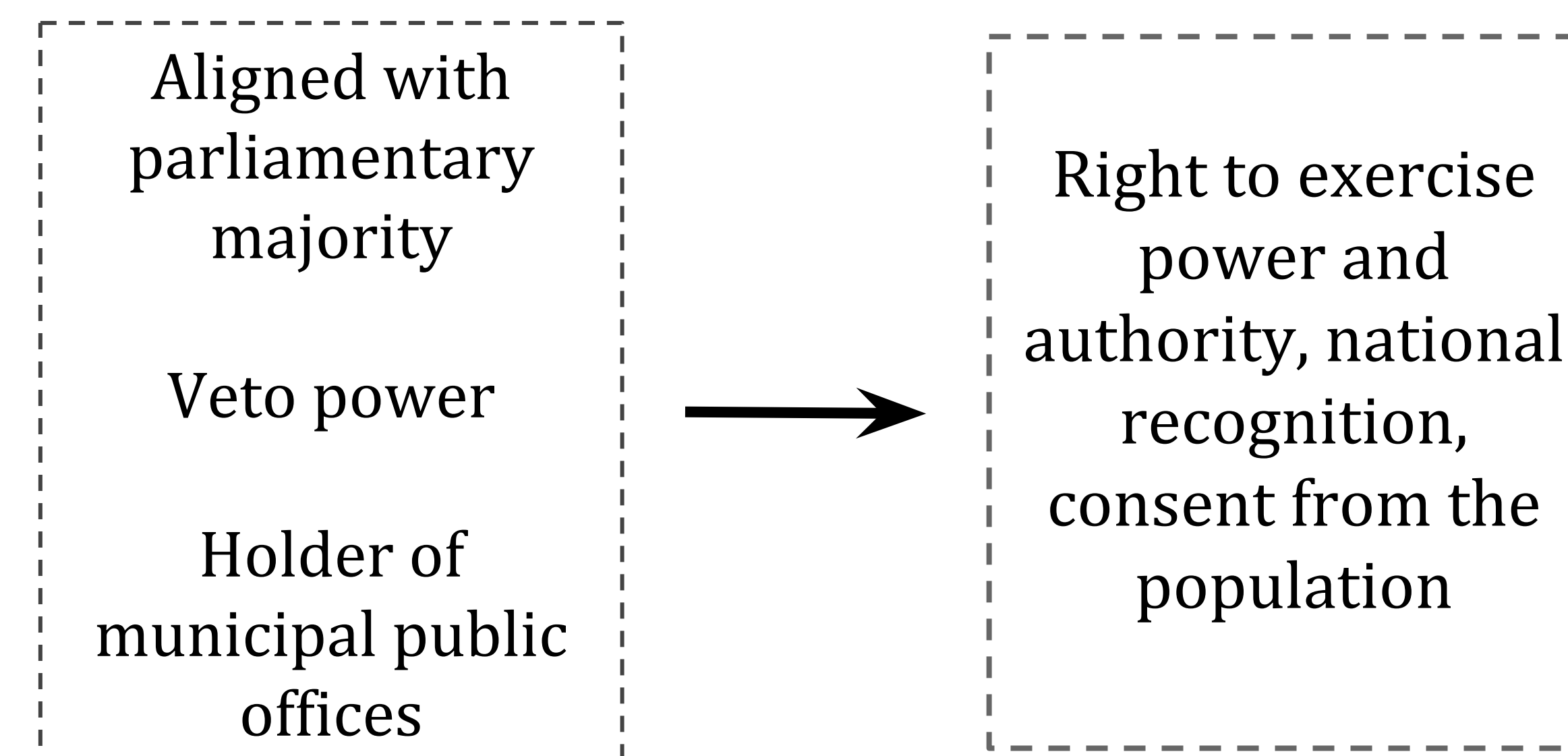
Argument & Empirical Analysis

Hezbollah's success is due to its political legitimacy, which is obtained and consolidated by:

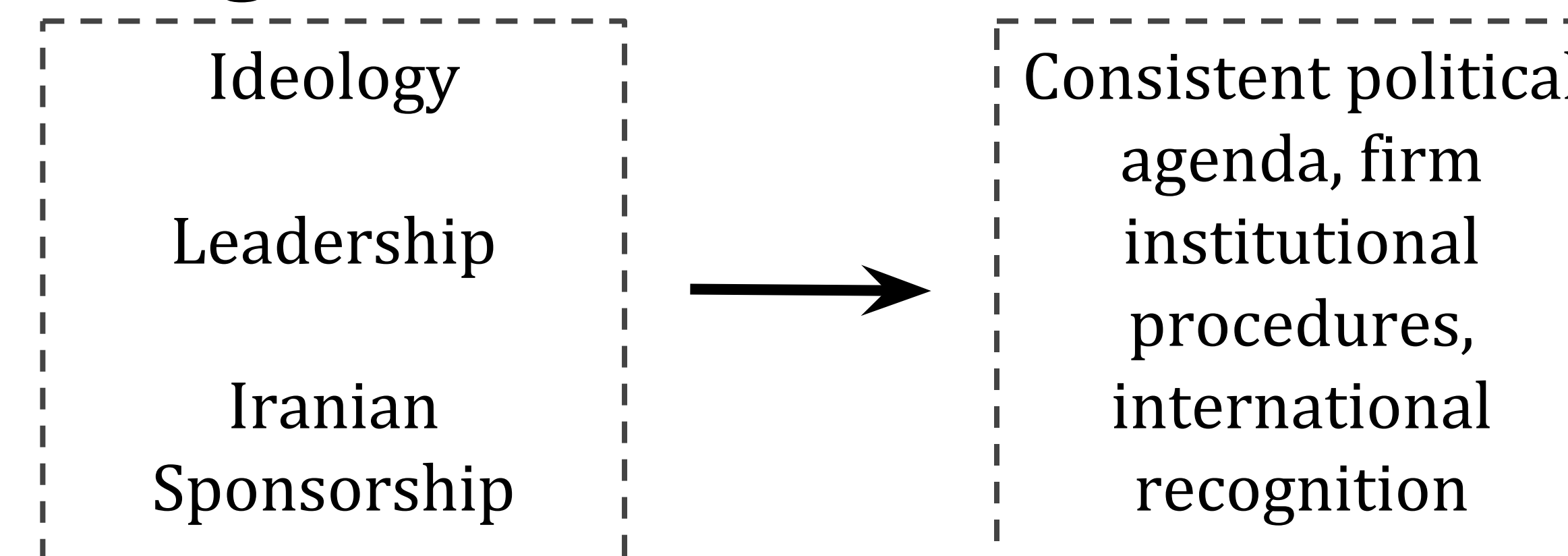
1. Welfare provision



2. Political Power

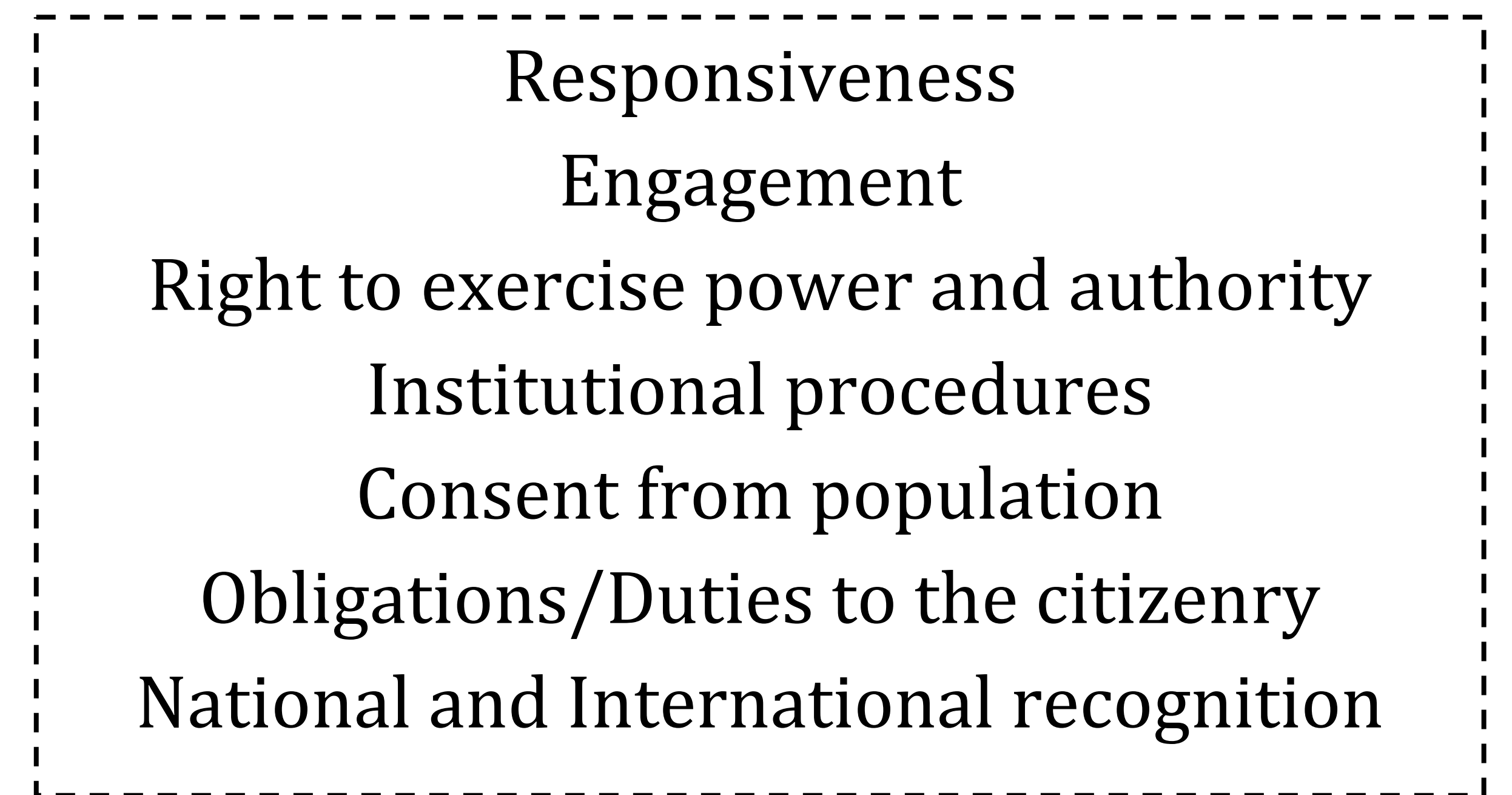


3. Organizational Characteristics

Conclusions

An in-depth exploration of Hezbollah's welfare provision, political power, and organizational characteristics reveals the contribution of these to Hezbollah's political legitimacy and their predictive power regarding non-state governance success.

The findings further reveal that non-state governance success cannot be attributed to one single factor, but is rather predicted by a multiplicity of them. The studied factors are generalizable to other cases and can aid in predicting levels of legitimacy and success of existing and/or newly emerging non-state governance actors.
