<u>Course Description</u>: This course explores seminal law and policy to inform contemporary civil rights and civil liberties jurisprudence. Specifically, the readings examine discrimination, housing inequality, economic inequality, freedom of speech and the press, the right to privacy, reproductive freedom, criminal procedure and adjudication, the rights of the criminally accused and the death penalty.

Requirements and Policies:

- Students are required to attend all classes
- No laptops or electronics permitted in class
- Discussion Sections are conducted every other week and students are encouraged to attend one of the two sessions (Tuesdays from 6:00-6:50pm and Wednesdays from 12:10-1:00pm)

<u>Learning Objectives:</u> This course will provide students with a working knowledge of the legal method of inquiry, as it pertains to matters of constitutional interpretation and adjudication. Civil rights and civil liberties will be assessed in their legal context. Specifically, students will learn to:

- 1. Read and analyze judicial opinions.
- 2. Identify the various constitutional standards of judicial review.
- 3. Apply legal and analytical constructs.

- 4. Evaluate the merits and shortcomings of theoretical debates within the civil liberties discourse
- 5. Analyze and assess contemporary scholarly and journalistic writings on civil rights and civil liberties by critically examining their claims and applicable counterpoints.
